

Event liability waiver

Participation in the event

I voluntarily choose to attend and participate, or give permission for the participant named in this form to attend and participate, in **[Event Name]** organised by **[Organiser Name]**.

The event may include:

- Group activities
- Entertainment
- Games or competitions
- Physical or recreational activities
- Workshops or demonstrations
- Food and refreshments
- Use of event facilities and equipment
- Travel between event areas
- Indoor or outdoor activities
- Activities provided by third-party vendors

I understand that participation is voluntary and that I may decline or stop taking part in any activity.

The organiser may modify, restrict, postpone or cancel any part of the event because of weather, safety concerns, attendance, venue conditions or other reasonable circumstances.

Tickets, bookings, deposits and fees remain subject to the organiser's cancellation and refund policies.

Participant eligibility

I confirm that the participant meets any age, health, ability or other eligibility requirements communicated by the organiser.

Where I sign for a minor or another person who cannot legally provide their own consent, I confirm that I am their parent, legal guardian or otherwise legally authorised to provide consent on their behalf.

I confirm that the participant is physically and mentally capable of taking part safely, except for any condition or limitation disclosed to the organiser before participation.

The organiser may refuse, restrict or end participation where it reasonably believes that a participant presents a safety risk to themselves or others.

Health and medical information

I agree to tell the organiser about any condition that may reasonably affect safe participation, including:

- A current injury or physical limitation
- A heart, circulation or blood-pressure condition
- Asthma or another breathing condition
- Diabetes
- Epilepsy, seizures, fainting or loss of consciousness
- Allergies or previous serious allergic reactions
- Pregnancy or possible pregnancy where relevant
- Recent surgery or medical treatment
- Medication that may affect coordination, judgment or alertness
- A restriction recommended by a healthcare professional
- A need for medication, additional support or reasonable adjustments

I understand that event staff are not medical professionals unless expressly stated otherwise.

The organiser may recommend medical clearance or restrict participation where there are reasonable health or safety concerns.

I will stop participating and inform a member of staff if I experience pain, dizziness, breathing difficulty, weakness or another concerning symptom.

Event risks

I understand that attending and participating in an event may involve ordinary and inherent risks that cannot be completely eliminated.

Depending on the event, possible risks may include:

- Slips, trips and falls
- Cuts, bruises and abrasions
- Strains, sprains and fractures
- Collisions with people, equipment or objects
- Crowded or congested areas
- Physical exertion and fatigue
- Heat, cold, rain, wind or other weather conditions
- Dehydration or heat-related illness

- Loud noise, flashing lights or visual effects
- Food allergies or adverse reactions
- Exposure to contagious illness
- Equipment failure or misuse
- Acts or conduct of other attendees
- Loss of or damage to personal belongings
- Serious injury, permanent disability or, in rare cases, death

I understand that the specific risks depend on the nature of the event, the venue, the activities offered, environmental conditions and my own health and conduct.

I voluntarily accept the ordinary and inherent risks of attendance and participation.

Safety rules and conduct

I agree to follow all reasonable instructions, event rules and safety requirements.

I will:

- Remain within authorised event areas
- Follow signs, barriers and staff instructions
- Use equipment only as directed
- Wear required protective equipment
- Report injuries, hazards or unsafe behaviour
- Respect staff, performers, vendors and other attendees
- Avoid reckless, threatening or disruptive conduct
- Stop participating when instructed
- Follow emergency and evacuation procedures

I will not:

- Enter restricted or staff-only areas
- Interfere with safety equipment
- Deliberately damage event or venue property
- Bring prohibited or dangerous items
- Harass, threaten or intentionally harm another person
- Participate while impaired or medically unfit

The organiser may remove a participant who ignores safety rules, behaves dangerously or seriously disrupts the event.

Removal for misconduct may not result in a refund.

Alcohol, drugs and impairment

I will not participate in activities while impaired by:

- Alcohol
- Recreational or illegal drugs
- Medication that affects judgment, coordination or alertness
- Fatigue, illness or another condition that makes participation unsafe

Where alcohol is available, I agree to drink responsibly and follow all applicable age and licensing requirements.

I understand that the organiser may refuse entry, restrict participation or remove a person who appears impaired or behaves unsafely.

Venue and third-party services

I understand that the event may take place at a venue not owned or directly controlled by the organiser.

The event may also include products, services or activities provided by independent vendors, contractors, performers, caterers, transport providers or venue operators.

Separate terms, waivers or safety requirements may apply to certain third-party activities.

The organiser is not responsible for the independent acts or omissions of third parties where those matters are outside the organiser's reasonable control, except where applicable law provides otherwise.

Food and allergies

Where food or drinks are available, I am responsible for checking whether they are suitable for me or the participant.

I agree to disclose any serious allergy or dietary restriction where the organiser has requested that information.

I understand that the organiser may not be able to guarantee that food or preparation areas are completely free from allergens or cross-contamination.

I will seek immediate assistance if I experience or observe a serious allergic reaction.

Photography and recordings

I understand that photographs, video or audio recordings may be taken in public or shared areas of the event.

Any use of identifiable images for promotional purposes should be handled according to the organiser's photography notice, privacy policy and applicable law.

Where separate consent is required, the organiser should obtain it through an appropriate photo consent form.

I agree not to record another person in a way that violates their privacy, safety or legal rights.

Personal belongings

I understand that personal belongings may be lost, stolen or damaged during the event.

I am responsible for protecting phones, bags, clothing, equipment, jewellery and other personal property.

I agree not to bring valuable, fragile or unnecessary items.

To the fullest extent permitted by applicable law, the organiser is not responsible for ordinary loss, theft or damage to personal belongings unless caused by liability that cannot legally be excluded.

Property damage

I accept responsibility for damage caused by my intentional conduct, reckless behaviour, prohibited activity or deliberate misuse of event or venue property.

I am not responsible for ordinary wear and tear or damage not caused by me.

The organiser may seek reasonable repair, replacement or cleaning costs where permitted by law.

Emergency assistance

If the participant becomes ill or injured, I authorise the organiser and event staff to:

- Provide reasonable first aid
- Stop the participant from continuing
- Contact an emergency contact
- Contact emergency medical services
- Arrange transportation to an appropriate healthcare facility
- Share relevant information with emergency responders
- Take reasonable action to protect the participant's immediate safety

I understand that the organiser cannot guarantee that an emergency contact will be reached before assistance is provided.

I accept responsibility for medical, ambulance and treatment expenses unless applicable law or legally established liability requires otherwise.

Assumption of risk

I knowingly and voluntarily accept the ordinary and inherent risks associated with attending and participating in the event.

I accept responsibility for injuries, losses or complications caused or materially contributed to by:

- Relevant information I concealed or provided inaccurately
 - A health condition or limitation I failed to disclose
 - My failure to follow reasonable safety rules or instructions
 - My misuse of equipment or facilities
 - My reckless, unlawful or prohibited conduct
 - My participation while impaired or medically unfit
 - My entry into a restricted or unauthorised area
 - Events outside the organiser's reasonable control

Liability release

To the fullest extent permitted by applicable law, I release **[Organiser Name]**, the event venue and their respective owners, directors, employees, volunteers, contractors and representatives from claims arising solely from:

- Ordinary and inherent event risks knowingly accepted in this form
- Relevant information I concealed or provided inaccurately
- My failure to follow reasonable safety rules or staff instructions

- My reckless, unlawful or prohibited conduct
- My intentional misuse of equipment, facilities or event property
- The conduct of another attendee or independent third party where it was outside the organiser's reasonable control
- Weather, venue conditions and other events outside the organiser's reasonable control

This release does not exclude or limit liability that cannot legally be excluded or limited.

It does not apply to fraud, intentional misconduct, gross negligence, reckless conduct, breaches of mandatory safeguarding duties, violations of mandatory consumer rights or any other liability that applicable law prohibits the organiser from waiving.

Participants under the legal age of consent

Where I sign on behalf of a minor or dependant, I confirm that:

- I am legally authorised to provide consent.
- I have provided accurate health and support information.
- I understand the nature and risks of the event.
- I give permission for the participant to attend and take part.
- I agree to help ensure that the participant follows all event rules.
- I authorise reasonable emergency assistance where necessary.

The organiser remains responsible for complying with applicable supervision, safeguarding and child-protection requirements.

Privacy and recordkeeping

I understand that the organiser may collect and retain information where reasonably necessary to:

- Register and identify attendees
- Manage tickets, bookings and participation
- Communicate event information
- Understand relevant health or support needs
- Maintain consent, safety and incident records
- Respond to injuries, complaints or legal claims
- Meet insurance, safeguarding and legal obligations

Information will be handled according to the organiser's privacy notice and applicable data-protection laws.

Final declaration

By completing and signing this form, I confirm that:

- I have read and understood the entire waiver.
 - The information provided is complete and accurate.
 - The participant meets the event's eligibility requirements.
 - I understand the nature of the event and its activities.
 - I understand and accept the ordinary and inherent risks.
 - I agree to follow all event rules and staff instructions.
 - I will not participate while impaired or medically unfit.
 - I authorise reasonable emergency assistance where necessary.
 - I had an opportunity to ask questions before signing.
 - Attendance and participation are voluntary.
 - I understand that this form does not remove rights or protections that cannot legally be waived.
