

Hair salon consent form

Salon services

I voluntarily request and consent to receiving the hair salon services discussed with my stylist.

These services may include hair cutting, colouring, bleaching, toning, highlighting, chemical straightening, relaxing, perming, extensions, washing, drying, heat styling or other agreed treatments.

I confirm that I have discussed the requested service, expected outcome and relevant hair history with my stylist.

I understand that the stylist may need to adjust, postpone or refuse a service where they reasonably believe it may cause excessive damage, create a safety risk or produce an unsuitable result.

I may ask the stylist to pause or stop the service at any time. However, completed work, mixed or used products, deposits and reserved appointment time may remain chargeable under the salon's payment policy.

Hair and health information

I understand that previous chemical treatments, colour products, medications, allergies, scalp conditions and the current condition of my hair may affect the safety and outcome of the service.

I agree to tell the stylist about relevant information, including:

- Previous colour, bleach, henna or metallic-salt products
- Previous perming, relaxing or chemical-straightening treatments
- Hair extensions, bonding products or adhesive treatments
- Damaged, fragile, thinning or excessively dry hair
- Scalp irritation, wounds, rashes, infections or skin conditions
- Allergies or previous reactions to hair products
- Medication or medical treatment that may affect my hair, scalp or skin
- Pregnancy or possible pregnancy where it may be relevant to the requested service

I confirm that the information I provide is complete and accurate to the best of my knowledge.

The stylist is not a medical professional and cannot determine whether a salon service is medically appropriate for me.

Patch and strand testing

I understand that the salon may recommend or require a patch test, allergy alert test or strand test before certain colouring or chemical services.

A patch or strand test may help identify certain reactions or assess how my hair may respond, but it does not guarantee that an allergic reaction, irritation, breakage or unexpected result will not occur.

I agree to follow any instructions provided for the test and to tell the salon immediately if I experience redness, itching, swelling, burning, irritation or another reaction.

The salon may refuse or postpone a service when a required test has not been completed, the result indicates a possible reaction or the stylist believes it would be unsafe to continue.

Colour and chemical service results

I understand that hair colour and chemical-service results vary depending on factors including:

- My natural hair colour and texture
- Previous colouring and chemical treatments
- Hair porosity, strength and condition
- Product buildup, mineral deposits or environmental exposure
- The accuracy of the information I provide
- How my hair reacts during the service
- Home care and products used after the appointment

The final result may differ from photographs, colour swatches, digital references or previous results.

Achieving the requested colour or style may require several appointments. Additional services, corrective colour, maintenance or home-care products may involve additional costs.

The salon and stylist cannot guarantee an exact shade, tone, texture, duration or final appearance.

Risks and possible complications

I understand that hair salon services involve risks that cannot be completely eliminated.

Possible risks and complications include:

- Skin or scalp irritation
- Itching, redness, swelling or allergic reactions
- Chemical or thermal burns
- Eye irritation
- Hair dryness, weakness, breakage or loss

- Changes in hair texture or curl pattern
- Uneven colour, unexpected tones, fading or colour transfer
- Scalp tenderness or sensitivity
- Staining of the skin, scalp or clothing
- Irritation or damage caused by adhesives, extensions or removal products
- Cuts, scratches or discomfort during cutting or styling
- An outcome that differs from my expectations
- The need for corrective services or additional treatments

I understand that chemically treated, lightened, damaged or fragile hair may be more likely to experience breakage or an unexpected result.

I agree to tell the stylist immediately if I experience burning, intense discomfort, breathing difficulty, swelling or another concerning reaction during the service.

Hair extensions

Where my service includes hair extensions, I understand that extensions may place additional tension or weight on my natural hair and scalp.

Improper maintenance, delayed removal, unsuitable products or failure to follow aftercare instructions may contribute to tangling, matting, breakage, thinning, discomfort or damage to my natural hair.

I understand that extensions require ongoing maintenance and may need to be repositioned, replaced or professionally removed.

The salon is not responsible for problems caused by incorrect home care, third-party adjustments or removal performed outside the salon.

Aftercare and maintenance

I agree to follow the stylist's reasonable aftercare and maintenance instructions.

I understand that the longevity and appearance of my colour, style, treatment or extensions may be affected by:

- Washing frequency
- Water temperature and water quality
- Sun, chlorine and saltwater exposure
- Heat styling
- Products used at home

- Failure to attend recommended maintenance appointments
- Additional colouring or chemical services performed elsewhere

I understand that failing to follow aftercare instructions may contribute to fading, dryness, tangling, breakage, colour changes or an unsatisfactory result.

I will contact the salon promptly if I have concerns about the service. I will seek appropriate medical care if I experience a serious or continuing reaction.

Personal belongings and clothing

I understand that salon products, colour and bleach may stain clothing or personal belongings.

I agree to use any protective cape, towel or covering provided by the salon and to keep valuable or delicate belongings away from the service area.

To the fullest extent permitted by law, the salon is not responsible for staining or damage where reasonable protective measures were provided and the damage was not caused by the salon's negligence or misconduct.

Assumption of risk and liability release

I knowingly and voluntarily accept the ordinary and inherent risks associated with the requested hair salon services.

To the fullest extent permitted by applicable law, I release **[Salon Name]**, the stylist and their owners, employees, contractors and representatives from claims arising solely from:

- Ordinary and inherent risks that I knowingly accepted
- Relevant information I concealed or provided inaccurately
- Previous treatments, products or hair conditions I did not disclose
- My failure to follow reasonable preparation, aftercare or maintenance instructions
- Products or treatments applied by me or another provider after leaving the salon
- Events occurring outside the salon's reasonable control

This release does not exclude or limit liability that cannot legally be excluded or limited.

It does not apply to fraud, intentional misconduct, gross negligence, reckless conduct, violations of mandatory consumer rights or any other liability that applicable law prohibits the salon from waiving.

Privacy and recordkeeping

I understand that the salon may collect and retain my information where reasonably necessary to:

- Provide and manage salon services
- Record consultations, formulas, treatments and test results
- Maintain consent and safety records
- Respond to complaints, reactions or legal claims
- Meet insurance, licensing and other legal obligations

My information will be handled according to the salon's privacy notice and applicable data-protection laws.

Final declaration

By completing and signing this form, I confirm that:

- I have read and understood this entire form.
 - The information I provide is complete and accurate.
 - I have disclosed relevant allergies, reactions, hair treatments and scalp conditions.
 - I understand the requested service and its possible risks.
 - I understand that results vary and cannot be guaranteed.
 - I agree to follow the stylist's preparation and aftercare instructions.
 - I had an opportunity to ask questions before signing.
 - I voluntarily consent to receiving the agreed salon services.
 - I understand that this form does not remove rights or protections that cannot legally be waived.
