

Laser tag waiver

Participation in laser tag activities

I voluntarily choose to participate, or give permission for the participant named in this form to participate, in laser tag activities provided or organised by **[Laser Tag Facility Name]**.

Laser tag activities may include:

- Recreational games and team matches
- Competitive or timed sessions
- Movement through indoor or outdoor arenas
- Use of laser tag equipment, vests, sensors and accessories
- Darkened, flashing or low-visibility environments
- Obstacles, ramps, barriers and themed structures
- Group events, parties and organised activities

I understand that participation is voluntary and that the participant may stop taking part at any time.

The facility may refuse, restrict or end participation if it reasonably believes that a participant is unable to participate safely, has failed to follow instructions or presents a risk to themselves or others.

Bookings, deposits and fees remain subject to the facility's cancellation and refund policies.

Participant eligibility

I confirm that the participant meets the facility's applicable age, height and participation requirements.

Where I sign for a minor or another person who cannot legally provide their own consent, I confirm that I am their parent, legal guardian or otherwise legally authorised to provide consent on their behalf.

I confirm that the participant is physically and mentally capable of participating safely, except for any condition or limitation disclosed to the facility before participation.

The facility may refuse participation where there are reasonable health or safety concerns.

Laser tag risks

I understand that laser tag is a physical activity involving movement, reduced lighting, obstacles, equipment and interaction with other participants.

Possible risks include:

- Slips, trips and falls

- Collisions with walls, barriers, equipment or other participants
- Cuts, bruises and abrasions
- Muscle strains, sprains and fractures
- Head, neck, back or joint injuries
- Temporary eye discomfort caused by lighting effects
- Dizziness, disorientation or loss of balance
- Anxiety, panic or emotional distress
- Physical fatigue or dehydration
- Aggravation of an existing injury or medical condition
- Equipment failure or misuse
- Serious injury or, in rare cases, permanent harm

I understand that low lighting, flashing lights, sound effects, fog effects and unfamiliar surroundings may make movement more difficult.

I understand that the facility cannot eliminate every risk associated with participation.

I voluntarily accept the ordinary and inherent risks of laser tag.

Health and physical condition

I agree to inform the facility about any condition that may affect safe participation, including:

- Epilepsy, seizures or sensitivity to flashing lights
- A history of fainting, dizziness or loss of consciousness
- Heart, circulation or blood-pressure conditions
- Asthma or another breathing condition
- Vision, balance or mobility difficulties
- A current injury or physical limitation
- A recent surgery or medical procedure
- Pregnancy or possible pregnancy
- Anxiety, panic attacks or sensitivity to enclosed or dark spaces
- Medication that may affect judgment, coordination or alertness
- A restriction recommended by a healthcare professional

I understand that facility staff are not medical professionals unless expressly stated otherwise.

The facility may limit or refuse participation if it reasonably believes that laser tag may be unsafe for the participant.

I will stop participating and inform a staff member if I experience pain, dizziness, breathing difficulty, confusion, visual discomfort or another concerning symptom.

Safety briefing and facility rules

I agree to attend and follow the facility's safety briefing.

I will follow all instructions from staff, game marshals and authorised representatives.

I agree to:

- Walk carefully and remain aware of my surroundings
- Follow all arena boundaries and restricted-area rules
- Use equipment only as instructed
- Keep aisles, exits and access points clear
- Follow all game-start and game-stop instructions
- Immediately stop when directed by staff
- Report injuries, hazards and damaged equipment
- Treat staff and other participants respectfully

I understand that completing a safety briefing does not guarantee that accidents or injuries will not occur.

Prohibited conduct

I agree not to:

- Run where running is prohibited
- Push, tackle, strike or intentionally collide with another participant
- Climb on walls, barriers, props or equipment unless expressly permitted
- Crawl into restricted or unsafe spaces
- Block emergency exits or access points
- Throw, drop or deliberately damage equipment
- Cover, alter or interfere with sensors
- Use equipment outside the authorised playing area
- Engage in threatening, abusive, reckless or dangerous behaviour
- Continue playing after being instructed to stop

The facility may immediately remove a participant who ignores safety rules or behaves dangerously.

A participant removed for serious misconduct may not be entitled to a refund.

Equipment use

I agree to use laser tag equipment only for its intended purpose and according to staff instructions.

I will not tamper with, dismantle, throw or misuse any vest, sensor, tagger or other equipment.

I will immediately report equipment that appears damaged, loose, uncomfortable or unsafe.

I accept responsibility for damage caused by intentional misconduct, reckless behaviour or deliberate misuse.

I am not responsible for ordinary wear and tear or pre-existing equipment damage.

Arena conditions

I understand that the arena may contain:

- Low lighting or darkness
- Flashing or coloured lights
- Loud music and sound effects
- Fog or visual effects
- Walls, barriers and themed structures
- Ramps, steps or changes in floor level
- Narrow or confined areas
- Other participants moving in different directions

I agree to move at a speed appropriate to the environment and remain aware of nearby obstacles and participants.

I will not enter closed, staff-only or restricted areas.

Clothing and personal belongings

I agree to wear suitable clothing and closed, secure footwear.

Loose clothing, scarves, jewellery and personal items may create a risk of tripping, catching or loss.

I am responsible for securing phones, glasses, jewellery and other personal property.

To the fullest extent permitted by applicable law, the facility is not responsible for ordinary loss, theft or damage to personal belongings unless caused by liability that cannot legally be excluded.

Alcohol, drugs and impairment

I will not participate while impaired by:

- Alcohol
- Recreational or illegal drugs
- Medication that affects coordination, judgment or alertness
- Fatigue, illness or another condition that makes participation unsafe

I understand that the facility may refuse or end participation if it reasonably believes that a participant is impaired or unable to participate safely.

Participant conduct

I accept responsibility for my conduct during the activity.

I understand that I must respect other participants, staff, equipment and facility property.

I agree not to deliberately frighten, harass, threaten or physically interfere with another participant.

I understand that the facility may separate participants, pause a game or end a session where necessary to protect safety or maintain appropriate conduct.

Emergency assistance

If the participant becomes ill or injured, I authorise the facility and its staff to:

- Provide reasonable first aid
- Stop the participant from continuing
- Contact an emergency contact
- Contact emergency medical services
- Arrange transportation to an appropriate healthcare facility
- Share relevant information with emergency responders
- Take reasonable action to protect the participant's immediate safety

I understand that the facility cannot guarantee that an emergency contact will be reached before assistance is provided.

I accept responsibility for medical, ambulance and treatment expenses unless applicable law or legally established liability requires otherwise.

Assumption of risk

I knowingly and voluntarily accept the ordinary and inherent risks associated with laser tag participation.

I accept responsibility for injuries, losses or complications caused or materially contributed to by:

- Relevant information I concealed or provided inaccurately
 - A health condition or limitation I failed to disclose
 - My failure to follow safety rules or staff instructions
 - My reckless, aggressive, unlawful or prohibited conduct
 - My misuse of equipment or facility property
 - My participation while impaired or medically unfit
 - My entry into a closed or restricted area

Liability release

To the fullest extent permitted by applicable law, I release **[Laser Tag Facility Name]** and its owners, directors, employees, game marshals, contractors and representatives from claims arising solely from:

- Ordinary and inherent laser tag risks knowingly accepted in this form
- Relevant information I concealed or provided inaccurately
- My failure to follow reasonable safety instructions
- My reckless, unlawful or prohibited conduct
- My intentional misuse of equipment or facility property
- The actions of another participant where they were outside the facility's reasonable control
- Events outside the facility's reasonable control

This release does not exclude or limit liability that cannot legally be excluded or limited.

It does not apply to fraud, intentional misconduct, gross negligence, reckless conduct, breaches of mandatory safeguarding duties, violations of mandatory consumer rights or any other liability that applicable law prohibits the facility from waiving.

Privacy and recordkeeping

I understand that the facility may collect and retain information where reasonably necessary to:

- Register and identify participants
- Confirm consent and eligibility
- Manage bookings, games and events
- Maintain safety and incident records
- Contact participants or emergency contacts
- Respond to injuries, complaints or legal claims
- Meet insurance, safeguarding and legal obligations

Information will be handled according to the facility's privacy notice and applicable data-protection laws.

Final declaration

By completing and signing this form, I confirm that:

- I have read and understood the entire waiver.
 - The information provided is complete and accurate.
 - The participant meets the facility's participation requirements.
 - I understand that laser tag involves physical activity and possible injury.
 - I understand and accept the ordinary and inherent risks.
 - I agree to follow all staff instructions and safety rules.
 - I will not participate while impaired or medically unfit.
 - I authorise reasonable emergency assistance where necessary.
 - I had an opportunity to ask questions before signing.
 - Participation is voluntary.
 - I understand that this form does not remove rights or protections that cannot legally be waived.
